



## Graduation Notification/Agreement and Notification for Not Meeting Requirements

Topic: Helping Students Navigate the Path to College

**Practice: Prepare Students Academically** 

Crossland High School places a strong emphasis on communicating student progress with parents and students. Using the *Graduation Notification/ Agreement*, counselors record a student's remaining service learning hours and course credits and any financial obligations to be reconciled before graduation. Counselors then review the document with the student to ensure he or she is on track for graduation and knows of any deficiencies before it is too late to address the problem.

If the student has not fulfilled all requirements by the end of senior year, parents receive a *Notification for Not Meeting Requirements* letter, which explains the remaining obligation(s). Schools can use these documents as a model for clearly communicating graduation requirements.
